



## Evaluation Report for Category B, Subcategory B.4.1 Application

### Purpose of Application

The purpose of this application was to convert the registration status of the end-use product Pristine WG Fungicide (Registration Number 27985) from conditional to full registration. The conversion to full registration for this product was contingent upon the conversion of the active ingredient Boscalid Technical Fungicide (Registration number 27494) and the associated end-use product Lance WDG Fungicide (Registration Number 27495). These prerequisite applications are now fully registered.

### Chemistry Assessment

A chemistry assessment was not required on this application.

### Health Assessments

An updated health risk assessment was conducted for handlers of Pristine WG Fungicide, which identified no unacceptable risk for mixer/loaders and applicators. Risk estimates to re-entry workers and bystanders are acceptable and remained unchanged from the original risk assessment published in the Regulatory Note REG2004-02, Boscalid/BAS 510. No unacceptable risk is expected when workers follow the label directions and wear the personal protective equipment identified on the label.

No new residue data were submitted to support this submission. The prerequisite submission# 2005-3930/3932 to convert the conditionally registered Boscalid Technical Herbicide and associated end-use products to full registration has been reviewed and the food residue exposure was considered acceptable. Therefore, the dietary exposure is not expected to increase and will not pose an unacceptable risk to any segment of the population, including infants, children, adults and seniors.

## **Environmental Assessment**

No additional environmental data were required to convert the registration of Pristine WG Fungicide from conditional to full. Environmental concerns such as the persistence of boscalid in the environment, and risks to aquatic organisms, non-target terrestrial plants and wild mammals resulting from the use of Pristine WG Fungicide have been mitigated through adequate statements on the product label.

## **Value Assessment**

A value assessment was not required to support the conversion of Pristine WG Fungicide to full registration.

## **Conclusion**

The PMRA has completed the assessment of all available information and are able to support the conversion of Pristine WG Fungicide from conditional to full registration.
