Purpose of Application

The purpose of this submission was to register a new manufacturing concentrate based on a precedent end-use product (PCP# 18450) from the same registrant.

Chemistry Assessment

Atrazine Base Mix Manufacturing Concentrate is a liquid suspension containing the active ingredient atrazine and related triazines at a nominal concentration of 57.8%. This product has a density of 1.13 g/mL and pH of 6.6. The chemistry requirements for Atrazine Base Mix Manufacturing Concentrate have been completed.

Health Assessments

Atrazine Base Mix Manufacturing Concentrate was considered toxicologically equivalent to the precedent product. Subsequently, no toxicological data are required.

Environmental and Value Assessment

Environmental and value assessments were not required for this application.

Conclusion

The Pest Management Regulatory Agency has completed an assessment of the information available in support of Atrazine Base Mix Manufacturing Concentrate and has found the information sufficient to support the registration of the new manufacturing concentrate.
