

## Evaluation Report for Category B, Subcategory 3.11 Application

### Background

Cotegra Fungicide (Reg. No. 32530) is a product containing boscalid (250 g a.i./L) and prothioconazole (150 g a.i./L) as the active ingredients. Cotegra Fungicide is registered for use on a variety of crops, including chickpea, lentil, and field pea (dry) to control or suppress certain diseases at rates between 0.6-1.0 L product/ha.

### Purpose of Application

The purpose of this application is to add a claim of suppression or control of anthracnose on lentil at 0.6-0.7 L product/ha and to add a claim of suppression of mycosphaerella blight and ascochyta blight on field pea (dry) at 0.7 L product/ha.

### Chemistry Assessment

A chemistry assessment was not required.

### Health and Environmental Assessments

Health and environmental assessments were not required.

### Value Assessment

The applicant submitted ten trials to support the claim against anthracnose on lentil. The data demonstrated that Cotegra Fungicide applied at 0.6 L product/ha can be expected to suppress anthracnose on lentil and Cotegra Fungicide applied at 0.7 L product/ha can be expected to control anthracnose on lentil.

The applicant submitted eight trials to support the claim against mycosphaerella blight and ascochyta blight on field pea (dry). The data demonstrated that Cotegra Fungicide applied at 0.7 L product/ha can be expected to suppress mycosphaerella blight and ascochyta blight on field pea (dry).

### Conclusion

The PMRA has completed an assessment of the subject application and concluded that the submitted value information is adequate to support a claim of suppression of anthracnose on lentils at 0.6 L product/ha, a claim of control of anthracnose on lentils at 0.7 L product/ha, and a claim of suppression of mycosphaerella blight and ascochyta blight on field peas (dry) at 0.7 L product/ha for Cotegra Fungicide.
