## **Purpose of Application**

The purpose of this application was to amend the formulation of the end-use product Busan 30WB Liquid Microbiocide.

### **Chemistry Assessment**

Busan 30WB Liquid Microbicide is formulated as an emulsifiable concentrate containing 2-(thiocyanomethylthio)benzothiazole at a concentration of 30%. This end-use product has a density of 1.09 - 1.11 g/cm<sup>3</sup> and pH of 4.5 - 6. The required chemistry data for Busan 30WB Liquid Microbicide have been provided, reviewed and found to be acceptable.

#### **Health Assessments**

The formulation amendment is not expected to have a significant impact on the acute toxicity profile of the product.

The occupational exposure and risk from the change in formulation to the Busan 30WB Liquid Microbiocide label were assessed. No risks of concern are expected from the new formulation, provided that workers follow the label directions and wear the personal protective equipment identified on the label.

A dietary exposure assessment was not required for this application.

#### **Environmental Assessment**

The amended formulation does not contain any formulants of environmental concern. The label includes all the required environmental precautions, hazards and directions for use statements, which adequately mitigates risks to the environment. Therefore, no additional risk is expected from the use of the amended formulation of Busan 30WB Liquid Microbicide.



## **Value Assessment**

The amended formulation was compared to the previous formulation of the product. The differences between the formulations were considered minor, and unlikely to result in any significant impact on product performance, in terms of efficacy. The formulation change has been found acceptable.

## **Conclusion**

The Pest Management Regulatory Agency has completed an assessment of the information provided, and has found it sufficient to support the amendment to the formulation of Busan 30 WB Liquid Microbiocide.
