Purpose of Application

The purpose of this application was to register a new domestic copper-releasing device for use in pools, spas and hot tubs, ClearBlue Ionizer A-800, based on the precedent commercial product owned by the same registrant.

Health Assessments

The concentrations of copper ions and other ions and elements in pool and spa water resulting from the use of the device are expected to be very low. Consequently, occupational and bystander exposures to these ions and elements from the installation, operation, and/or maintenance of the device or from bathing in or accidentally ingesting pool, spa, and/or hot tub water treated by the device are also expected to be very low.

Based on a consideration of these very low exposures and a review of drinking water guidelines and standards, the risk of human health effects from the copper ions and other ions and elements released from the device into pool, spa and hot tub water is acceptable.

Toxicology and dietary exposure assessments were not required for this application.

Value Assessment

A rationale to extrapolate from registered precedent products was acceptable to determine that ClearBlue Ionizer A-800 has acceptable value.

Chemistry and Environmental Assessments

Chemistry and environmental assessments were not required for this application.



Conclusion

The Pest Management Regulatory Agency has completed an assessment of the information provided, and has found it sufficient to support the registration of ClearBlue Ionizer A-800.
