# **Background**

Only pilot batch data was provided under application 2020-0622, therefore, a Section 12 Notice was issued on May 27, 2021 requesting GLP-compliant five batch data representing commercial-scale production at the approved manufacturing site.

### **Purpose of Application**

The purpose of this application was to fulfill the Section 12 Notice data requirements to support the registration of Acetamiprid Technical Insecticide at the approved manufacturing site.
