## **Background**

Zodiac Powerspot Flea & Tick Control for Dogs Under 14 kg (30 lbs) (Reg. No. 26494) is a spot-on dog product which is formulated with 45% permethrin and 2.9% (s)-methoprene. This product is registered with a claim to kill fleas (eggs, larvae, and adults) and ticks on dogs. The product is for use only on dogs over 6 months of age and under 14 kg in size. The product is applied at a rate of 1 ml product per dog with a reapplication interval of one month (4 weeks).

Permethrin is a pyrethroid insecticide which kills on contact by acting on the nervous system of insects. S-methoprene is an insect growth regulator that prevents the development of flea eggs and larvae into adult fleas.

### **Purpose of Application**

The purpose of this application is to add a claim of kills mosquitoes to the label of Zodiac Powerspot Flea & Tick Control for Dogs Under 14 kg (30 lbs).

#### **Value Assessment**

Three trials on dogs were reviewed in support of the addition of a claim against mosquitoes to the Zodiac Powerspot Flea & Tick Control for Dogs Under 14 kg (30 lbs) label. The submitted value information was sufficient to support a claim that Zodiac Powerspot Flea & Tick Control for Dogs Under 14 kg (30 lbs) will kill mosquitoes for up to one month when applied to dogs according to the labelled application rate (1 ml product for dogs over 6 months of age and under 14 kg).



#### Conclusion

The submitted information was sufficient to support a claim that Zodiac Powerspot Flea & Tick Control for Dogs Under 14 kg (30 lbs) will kill mosquitoes on dogs for up to one month when applied as a spot-on at a rate of 1 ml to dogs over 6 months of age and under 14 kg in size
