The original source of paclobutrazol technical grade active ingredient, "Paclobutrazol Technical" (Reg. No. 24198) was first registered in 1995.

Purpose of Application

The purpose of this application is to register a new technical source of paclobutrazol plant growth regulator by the same registrant and to amend the guarantee of the registered source from 90.0% minimum to 96.9% nominal.
