Purpose of Application

The purpose of this application is to update the product specifications for Deltamethrin Technical Insecticide (Reg. No. 18092).

Deltamethrin Technical Insecticide has the following properties:

Health Assessments

The change in product specification does not impact on the toxicological profile of Deltamethrin Technical Insecticide.

The increased amount of the active ingredient, and the lowering of impurities in the Deltamethrin Technical Insecticide formulation will not significantly increase the residues of deltamethrin in treated crops, as any possible change in the guarantee of the active ingredient in the deltamethrin end-use products would be minimal. Therefore, no increase in dietary exposure is anticipated. The change in product specifications will not pose an unacceptable risk to any segment of the population, including infants, children, adults and seniors.

Environmental Assessment

An environmental assessment was not required.

Value Assessment

A value assessment was not required.

Conclusion

The PMRA has completed an assessment of available information for Deltamethrin Technical Insecticide and has found the information sufficient to support the update of the product specifications.
