

Evaluation Report for Category B, Subcategory B.3.10 Application (New or Changes to Product Label – Tank Mixes)

Active Ingredients (a.i.): 175 g/L bromoxynil present as mixed octanoate and heptanoate esters,

31.3 g/L pyrasulfotole, and 5 g/L thiencarbazone-methyl

Purpose of Application

The purpose of this application is to amend the registration of Velocity M3 All-In-One Herbicide to include the amendments that are listed below:

- 1. Add the general tank mix statement as per the published PMRA Guidance Document Tank Mix Labelling.
- 2. Include additional tank mixing statements to accompany the general tank mixing statement above.
- 3. Include a restrictive statement for using in combination with other Group 27 Herbicides: *DO NOT tank-mix Velocity M3 All-In-One Herbicide with herbicides, containing the following active ingredients: bicyclopyrone (e.g., Talinor Herbicide) and tolpyralate (e.g., OnDeck Herbicide).*

Other minor label amendments were also proposed.

Chemistry, Health, and Environmental Assessments

Chemistry, health, and environmental assessments were not required as there was no change to product chemistry, product formulation, or use pattern.

Value Assessment

A thorough review of the label determined that the addition of the general tank mix statement is acceptable as it is consistent with the requirements in the PMRA Guidance Document – Tank Mix Labelling.

The inclusion of the general tank mixing statement on the label allows growers greater flexibility to select tank mixtures to control pests in labelled crops. Flexibility in the selection of tank mix partners may contribute to resistance management practices, integrated weed management programs, or the control of a broader range of pests, with an associated cost- and time-savings by the user.

Other label amendments, including the addition of additional tank mixing statements and the restrictive statement, are supported based on rationales and relevant precedent registrations.



Conclusion

The PMRA has completed an assessment of the subject application and has found the information sufficient to support all the requested amendments to the Velocity M3 All-In-One Herbicide label.
