Later's Creeping Buttercup Weed Killer

DIRECTIONS FOR USE: Later's Creeping Buttercup Weed Killer is a unique concentrated weed killer specially designed to eradicate creeping, hard to kill, noxious weeds including Creeping Buttercup, Fall Dandelion, Horsetail, Plantain and Spotted Cat's Ear. It will not harm lawn grass when used as directed. Apply anytime weeds are actively growing. Applications made in the late spring and early fall, when weeds are small, are most effective. Do not cut the grass for 4 days before and after spraying. Do not spray if rain is expected within 24 hours of application. Spray when the air is calm to avoid spray drift. After spraying, do not water the lawn for 24 hours. Newly seeded lawns may be treated after they have been mowed at least 3 times.

5 mL = 1 teaspoon
15 mL = 1 tablespoon

1 m = approx. 1 long pace
100 m² = 10 m x 10 m

HOW TO USE: SPRAYER: Mix 30 mL with 15 L of water and spray to cover 100 m². WATERING CAN: Mix 10 mL with 5 L of water and sprinkle over 30 m² (6 m x 5 m).

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Keep children and pets away from treated areas, at least until spray has dried. Avoid contact with eyes, skin and clothing. Wash hands and clothing after use. Use a clean sprayer and wash out thoroughly after use.

ENVIRONMENTAL HAZARDS: Do not use this product for controlling weeds in flower or vegetable beds or around shrubs or ornamental plantings. Do not reseed for 3 - 4 weeks after use. Do not use treated grass clippings as a mulch around desirable plants. Avoid spray drift onto susceptible plants. Do not contaminate streams, lakes or ponds.

FIRST AID: **If swallowed,** Call a poison control centre or doctor IMMEDIATELY for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **If in eyes,** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin,** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

STORAGE: Do not freeze. Keep product in original container. Store in a cool, dry place away from food, seeds, fertilizer, insecticides or fungicides.

DISPOSAL: Do not reuse empty container. Rinse thoroughly and use rinse water with regular spray. Wrap container and discard with household garbage.
