DIRECTIONS FOR USE:

Dilute the product two parts of water to one part S-2 (as received). Using conventional spray equipment, this material should be sprayed as uniformly as possible in order to thoroughly wet surface being treated. The application should be conducted in a spray booth or well ventilated area.

PRECAUTION:

KEEP OUT OF REACH OF CHILDREN. May be harmful if swallowed. Avoid contact with eyes and skin. Wash thoroughly after handling. Avoid contamination of food. Avoid breathing spray mist.

FIRST AID:

In case of contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. For eyes, hold eye open and rinse slowly and

gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
