DIRECTIONS FOR USE: CHEMCIDE #2 is recommended for use controlling microbial growth which cause fouling of industrial water based metalworking fluids. CHEMCIDE#2 is compatible with most soluble oils, semi-synthetic and synthetic metalworking fluids available today and when used as directed can be expected to extend the life of the fluid considerably.

For the maintenance of a nonfouled system add 2.3 L per 10,000 L of emulsion every 8-12 weeks. For a noticeable fouled system use initial dosage range of 4.6 - 5.6 L per 10,000 L followed by subsequent dosages depending upon the treatment level noted above. A high dosage range and/or increased frequency of treatment may be required depending on rate of dilution of the preservative with makeup fluid, the nature and severity of contamination, level of control required, filtration effectiveness, system design, etc. The preservative should be dispensed into the use-dilution of the metalworking fluid by a metering pump and uniformly dispersed throughout the system.

CHEMCIDE#2 weighs 1 kg. per litre.

FIRST AID: If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Avoid alcohol. Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsions may be needed.
