DIRECTIONS FOR USE:

INDUSTRIAL RECIRCULATING COOLING WATER SYSTEMS

Note: SOLID BIONOX is intended for use only with the provided feeder from Nalco Canada Co. Direct contact of SOLID BIONOX with a metal surface may cause local corrosion. To use, open the SOLID BIONOX packaging tube at one end. Squeeze tube at open end to hold tablets in tube. Invert tube and align open end over empty feeder. Release product from tube to load feeder. Avoid placing SOLID BIONOX in direct sunlight.

To control bacteria, fungi, and algae in clean to moderately contaminated systems, add one tablet per 1900 - 3800 L (500 - 1000 US gallons) of water in the system. Heavily

contaminated systems may require two tablets per 1900 - 3800 L (500 - 1000 US gallons) of water.

EACH TABLET OR GROUP OF TABLETS OF SOLID BIONOX WILL PROVIDE APPROXIMATELY 3 WEEKS OF CONTROL. Add additional tablet(s) of SOLID BIONOX per 1900 - 3800 L (500 - 1000US gallons) of water in the system every 3 weeks, or as needed to maintain control. Do not cut or divide individual tablets.

PRECAUTIONS:

CAUSES SEVERE EYE DAMAGE. EYE CONTACT MAY CAUSE LOSS OF VISION. MAY BURN THE SKIN. HARMFUL IF SWALLOWED. POTENTIAL SKIN SENSITIZER. Do not get in eyes, on skin, or on clothing. Chemical worker's goggles must be worn when handling or working near this chemical. Gloves must be worn when handling. Wash thoroughly after handling.

FIRST AID:
