DIRECTIONS FOR USE

Interior Applications: Such as PVC floor and wall coverings, coated fabrics for upholstery, interior automotive parts, refrigerator gaskets, shower curtains and mattress covers. Use 0.6% of this product based upon the total weight of the formulation. (6 lbs/1000 lbs of compound)

Exterior Applications: Such as automotive landau tops, exterior automotive trim, tarpaulins, awnings, ditch and pond liners, marine upholstery, swimming pool liners. Use 1.0% of this product based upon the total weight of the formulation. (10 lbs/1000 lbs of compound)

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN

Do not contaminate water, food or feed by storage or disposal. Open dumping prohibited. Do not reuse empty container.

Arsenic can be released during the use of this product.
