PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.

DANGER: CORROSIVE TO EYES - SKIN IRRITANT. Do not get on skin, in eyes or on clothing. Harmful if swallowed, inhaled or absorbed through skin. May be fatal if inhaled. Avoid inhalation of dust or spray mist. Wash contaminated clothing before reuse. Avoid alcohol.

FIRST AID:

If in contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment.

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Preservation of adhesives - To prevent bacterial degradation of dry starch and synthetic latex adhesive formulations (after water is added by end-user), add 0.185% to 0.5% of **VANCIDE MZ-96**, by weight of total composition, during adhesive manufacture.
