DIRECTIONS FOR USE

To be used only in the manufacture of antimicrobial products which are registered/scheduled under the *Pest Control Products Act*. Registrants are responsible for their own registrations.

PRECAUTION STATEMENTS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful if swallowed. CORROSIVE to the eye. DO NOT get in eyes. Corrosive to the skin. DO NOT get on skin. Harmful if inhaled. Avoid breathing vapour or mist. Wear goggles or a face shield, chemical-resistant gloves, long pants, a long-sleeved shirt, shoes, and socks when handling this product.
