DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS:

KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL.
