**DIRECTIONS FOR USE: SHAKE WELL BEFORE USING.** Spray plants to thorough wetting. For use on vegetables, fruits, ornamentals and flowering plants.

Powdery mildew: on roses, chrysanthemums, grapes, strawberries, currants, gooseberries, beans, dahlias. Concord grapes and other sulphur-shy varieties of plants may be sensitive to this product. Spray at first sign of disease and repeat at 10-14 day intervals.

Black Spot: on roses. Spray every 7-10 days to ensure thorough coverage of new foliage and stems.

Rust: on currants, gooseberries, beans and ornamentals. Spray at first sign of disease and repeat at 10-14 day intervals as necessary.

Preharvest Interval: Apply up to 1 day before harvest for all crops except wine grapes, which require a 21 day interval.

**PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN.** Do not apply within 30 days of an oil treatment or at high temperatures. Do not apply to Boston Fern. Avoid contamination of food and feed. Do not heat or store at high temperatures.  
**DISPOSAL:** Dispose of container in household garbage. Do not reuse empty container.  
**FIRST AID:** If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.  
**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

ENVIRONMENTAL HAZARDS: Do not apply directly to aquatic habitats (such as lakes, rivers, sloughs, ponds, coulees, prairie potholes, creeks, marshes, streams, reservoirs, and wetlands) and estuarine/marine habitats. Do not contaminate water by cleaning of equipment or disposal of wastes.
