PENTOX® ZIN-K-NAP® wood preservative solution, contains 2% zinc as zinc naphthenate in petroleum solvents. Used for the treatment of dry wood. Penetrates and preserves dry lumber such as beams, sub floors, sills, foundations, joists, rafters, farm buildings, docks, boats, boat houses and wood in proximity to, or contact with, ground or water. Wood treated with PENTOX® ZIN-K-NAP® solution will not injure plants provided that all solvents have evaporated from the treated wood before use. Treated wood can be painted when dry. If left unfinished, repeated application in the future will reinforce the treatment.

#### DIRECTIONS FOR USE

FOR EXTERIOR USE ONLY. Not for use in dwellings. For above ground use only. Apply by brush only. Do not spray or dip. Wood surface to be treated should be dry and clean. Remove all paint, varnish, wax, or any other coating that may prevent penetration. Ready to use - do not dilute. Brush on 2 liberal coats. Heavy lumber requires more treatment. Treat all new cuts and trims. Apply 1 liter per 6 to 8 square meters, depending on the porosity of the wood. Drying time: minimum 1 hour before handling. Wood may be painted as soon as surface is dry. Do not apply to any surface that may come in contact with food, feed, or drinking water, or where prolonged contact with skin may occur. Clean equipment (brushes, trays, etc.) with mineral spirits, then with detergent and water. Harmful to plant life when wet. Allow to dry thoroughly before permitting contact. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

## PRECAUTIONS & ENVIRONMENTAL HAZARDS

Harmful if swallowed, or inhaled. Causes skin and eye irritation. Potential skin sensitizer. Keep container closed when not in use. Keep out of reach of children and domestic animals. Keep solution away from plants, foodstuffs, and aquatic animals. Do not contaminate bodies of water. This product is toxic to aquatic organisms. Avoid, breathing vapours, contact with skin, eyes and clothing. Good ventilation is necessary while treating. Wear a long-sleeved shirt, long pants, socks, shoes, and rubber gloves when applying this product or handling wet freshly treated wood. Wash thoroughly after use with soap and water and before eating, smoking, or hand shaking. May cause skin irritation. Avoid skin contact. Flammable. Keep away from open flame, spark, or excessive heat while using, or in storage.

## FIRST AID

If on skin, promptly remove by washing with vegetable oil, or hand degreaser and then with soap and water. If irritation occurs, see physician.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
