PRECAUTIONS

Potential skin sensitizer. Causes eye and skin irritation. DO NOT get in eyes or on skin. Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing dust and contact with skin or eyes. The active ingredient ethalfluralin may cause skin sensitization reactions in certain individuals. Wear goggles and protective clothing such as coveralls, a long-sleeved shirt and impermeable gloves when handling this product.

FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If on skin: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION

No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.

AGRICULTURAL CHEMICAL

Do not ship or store with food, feeds, drugs or clothing.

ENVIRONMENTAL HAZARD

Direct contamination of any body of water with this product may kill fish. Do not contaminate any body of water by direct application, cleaning of equipment or disposal of wastes.

STORAGE

Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer, or other pesticides. Keep away from fire or open flame, or other sources of heat. Do not expose to temperatures greater than 40°C.

Completely empty fibre drum by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into manufacturing equipment. Do not reuse the container.
