For use as a crack and crevice treatment to control insects listed on front panel.

DIRECTIONS: SHAKE CONTAINER WELL. Insert the "applicator wand" into the spray nozzle before using. This product is designed for applying into cracks, crevices, or tight areas that are difficult to reach. Spray directly into cracks and crevices particularly under baseboards where cockroaches and other insects listed on the label like to go, and where the insecticide won't be mopped away. The foaming action of this formula completely fills tight crevices leaving an insecticidally active residue. Spray into hard to reach places, behind refrigerators, washers, under sinks, between cabinets, under counters and other places where these insects hide, such as around door and window frames.

KEEP PETS AND CHILDREN AWAY UNTIL RESIDUE IS DRY.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stove or other sources of heat, or store at temperatures over 50°C. FIRST AID: If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: When container is empty, press button to release all pressure, wrap, then dispose of in household garbage. Do not puncture or incinerate.
