DIRECTIONS FOR USE: To be used only in the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Wash thoroughly with soap and water after handling product and before eating, drinking or smoking. Wash contaminated clothing with soap and water before reuse. Do not wear contaminated shoes. Permits may be required for discharges containing this pesticide into lakes, ponds, streams or public waters. FIRST AID TREATMENT:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice.

Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

ENVIRONMENTAL HAZARDS: Toxic to aquatic organisms.

STORAGE: Store in the original container in a well ventilated room. Protect from heat or direct sunlight. Store in a dry place.
