To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

HARMFUL IF SWALLOWED

MAY CAUSE EYE AND SKIN IRRITATION

AVOID INHALING OR CONTACT WITH SKIN AND EYES

WEAR PROTECTIVE GOGGLES AND GLOVES WHEN HANDLING

FIRST AID

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

No specific antidote. Treat symptomatically. Treatment should be based on judgement of the physician in response to reactions of the patient.

High concentrations of MCPA may cause severe irritation to the eyes. Symptoms of overexposure to MCPA could include slurred speech, twitching, jerking and spasms, drooling, low blood pressure and unconsciousness.

STORAGE

Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer or other pesticides. Keep away from fire, open flames or other sources of heat.

DISPOSAL

Canadian formulators using this product should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations.

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for information on the clean up of spills.

CLEAN-UP INSTRUCTIONS
