DIRECTIONS FOR USE:

For paper, pulp and board mill addition use 0.3-0.5 kg per 1,000 kg of paper or pulp.
For paper machine washup, use 1.3 L for each 1,000 L of recirculating wash water.
Apply the product using a closed delivery system such as a dry coupling and/or metering pump.
Do not use in potable water supply. Not for use in the production of paper or paperboard that will come into contact with food.

PRECAUTIONS:

DANGER. Corrosive to eyes and skin. Wear chemical goggles and face shield, chemical-resistant gloves, long pants, a long-sleeve shirt, and shoes and socks when handling. Avoid getting in eyes, nose or on skin. Keep away from open flame or excessive heat. Remove contaminated clothing and wash before reuse.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
