DIRECTIONS FOR USE

To be used only in the manufacture of insecticides which are registered under the Pest Control Product Act. Read Technical Bulletin for formulation details.

PRECAUTIONS:

KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL. May be harmful or fatal if swallowed. Do not breathe fumes. Avoid contact with skin and eyes. In case of spillage on skin, remove with soap and water. In case of contact with eyes, flush with plenty of water. Avoid contamination of food or feedstuffs.

This product is toxic to fish. Do not contaminate any body of water by cleaning of equipment or disposal of wastes.

FIRST AID:

If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do **not** give any liquid to the person. Do not give anything by mouth to an unconscious person. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes.

Call a poison control centre or doctor for treatment advice. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
