DIRECTIONS FOR USE

To be used only in the manufacture of a fungicide or animal repellent which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS: KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL.

Do not inhale dust or spray mist. Do not get in eyes or on skin. Causes irritation to eyes, nose and skin. Use with adequate ventilation. Wash thoroughly after handling. Do not consume alcoholic beverages immediately before or within 24 hours after working with THIRAM 80% WP.

FIRST AID:

In case of contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

TOXICOLOGICAL INFORMATION
