**DIRECTIONS FOR USE:** To be used only in the manufacture of insecticides which are registered under the Pest Control Products Act. This product is designed for dilution with deodorized base oil in the manufacture of insecticidal space and contact sprays in which a 1:10 ratio of pyrethrins to technical piperonyl butoxide is desired.
