OSMOSE® End-Cut Wood Preservative Tan product is a water repellent wood preservative containing 2.35% zinc as in zinc naphthenate in petroleum solvents.

DIRECTIONS FOR USE

For exterior use only. Not for use in dwellings. For above ground use only. Apply by brush only. Do not spray or dip. Wood surface to be treated should be dry and clean.

Wood surface to be treated should be dry and clean. Remove all paint, varnish, wax, or any other coating that may prevent penetration. Allow to dry thoroughly before painting or re-coating.

Use as supplied - do not dilute. Do not apply to wood, or fabric, or any surface where prolonged skin contact may occur, or on any surface which may come into contact with food, feed or drinking water. Harmful to plant life when wet. Allow to dry thoroughly before permitting contact. . Clean equipment, (brushes, trays, etc) with mineral spirits then with detergent and water.

Treat all newcuts and trims. Drying time: minimum 1 hour before handling.

FOR FABRIC USE

For use only on exterior industrial fabric, duck cloth, awnings, etc..
Do not use on rubber coated fabric. Apply by brush, or swab only. Do not spray or dip.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. Keep container closed when not in use. Keep solution away from plants foodstuffs and aquatic animals (toxic to fish). Harmful if swallowed, or inhaled. Avoid, breathing vapours, contact with skin, eyes and clothing. Good ventilation is necessary while treating. Wear rubber or plastic gloves and appropriate covering clothing, when applying this product or handling wet freshly treated wood. Wash thoroughly after use with soap and water and before eating or smoking. May cause skin irritation. Do not use in saunas. Flammable. Do not use or store near open flame, spark, or excessive heat. Do not contaminate bodies of water. This product is toxic to fish.

FIRST AID

In case of skin or clothing contact, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If splashed in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person.
