To be used only in the manufacture of insecticides which are registered under the Pest Control Products Act. D-TRANS® Intermediate 1862 is to be used at the rate of 2.50% (wt.) with appropriate solvents, carriers and hydrocarbon propellents in the manufacture of water-base insecticide sprays.
