DIRECTIONS FOR USE:

To be used only in the manufacture or formulating of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS:

KEEP PRODUCT OUT OF REACH OF UNAUTHORIZED PERSONNEL. Strictly observe all precautions for handling and using pesticides. May be harmful if swallowed, inhaled or absorbed through skin. Do not breathe vapours. Avoid contact with skin, eyes and clothing.

Wear protective clothing including, coveralls/apron, chemical resistant gloves, mask/face shield, goggles and boots when handling, mixing or loading this product. Do not use, pour or spill near heat or open flame. Use in well-ventilated area. Wash thoroughly with soap and water after handling product and before eating, drinking, or smoking. Wash contaminated clothing with soap and water and separate from other laundry before reuse. This product is toxic to aquatic organisms and wildlife. Keep out of aquatic systems. FIRST AID TREATMENT:

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Contain Petroleum Distillates. Vomiting may cause aspiration pneumonia. Product may be absorbed by the respiratory route. Not absorbed to a significant degree through the skin and poorly through the gastrointestinal tract. In mild cases of ingestion: No active measures. In severe cases avoid regurgitation of oil in lungs. Give gastric lavage. In case of respiratory symptoms give oxygen and atropine.

STORAGE:

Store upright in the original, tightly sealed container in a well ventilated room. Store in a cool, dry place away from food, feed or other pesticides. Keep out of reach of unauthorized persons. Protect from sun and humidity. Do not store near heat or open flame.
