**DIRECTIONS FOR USE:**

DO NOT apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment. DO NOT administer by mouth. Shake bottle well before using. Wet cat or dog thoroughly with warm water. Apply shampoo and rub shampoo into coat beginning at the head and working backward until entire body is covered (approximately 5 mL/kg). Pay special attention to neck, hindquarters, areas under legs, around the tail and between toes. DO NOT treat eyes, face or genitals of the cat or dog. For difficult infestations, allow the lather to remain for 3 – 5 minutes. Rinse thoroughly to remove all traces of shampoo on the cat or dog's coat. DO NOT use on cats or dogs under 8 weeks of age. Do not treat nursing females. Do not use on sick cats or dogs. Do not use on cats or dogs under drug or pesticide treatment. Consult a veterinarian before using on pregnant cats or dogs. DO NOT use this shampoo more often than once every 2 weeks. Treatment must be repeated only if the pest problem reoccurs. DO NOT use solely as a shampoo when there is no pest problem.

For effective flea and tick control, treatment of the cat or dog should be combined with sanitation of any area used by the cat or dog. Vacuum floors, carpets and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters and surrounding areas. If pest problems persist, an insecticidal treatment of the premises may be required. A veterinarian should be consulted when flea infestation continues to be a problem on the pet. DO NOT apply to any body of water.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

Avoid application of this product when winds are gusty.

**PRECAUTIONS:**

**HUMANS:** KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed or absorbed through skin. May irritate eyes. Avoid contact with mouth, eyes, skin and clothing. Use ONLY in well-ventilated area, preferably outdoors. After handling or applying, wash hands (or any other skin that came into contact with the product) with soap and water. Avoid contact with treated cats or dogs until dried. DO NOT allow product to contact non-target surfaces. Avoid product contact with food, food utensils or places where food is prepared or stored. DO NOT apply using stationary or handheld fogging or misting equipment. DO NOT apply as a space spray. DO NOT apply to [furniture], [mattresses], linens, pet bedding, toys or clothing. This product contains pyrethrins and piperonyl butoxide. Do not apply another pest control product such as a shampoo, spot-on, spray, collar, or powder that contains pyrethrins or piperonyl butoxide to the treated animal after applying [name of spray/shampoo product]"

**PETS:** Harmful if swallowed. Rinse the pet thoroughly with water to remove all traces of shampoo. Avoid contact with cat or dog's mouth, face, eyes and genitals. Do NOT allow cat or dog to lick the suds from the coat or to ingest any of the shampoo. Monitor your dog after application. Side effects may include: skin irritation such as redness or scratching; changes in behaviour such as agitation or lethargy; or gastrointestinal effects such as vomiting or loss of appetite. If these or other side effects occur consult your veterinarian or 1-800-740-8712. Monitor your cat after application. Side effects may include: skin irritation such as scratching or hair loss at the application site, or changes in behaviour such as agitation or lethargy. Gastrointestinal effects such as drooling, vomiting, or loss of appetite may also occur. If these or other side effects occur consult your veterinarian Or 1-800-740-8712.

**FIRST AID:**

**HUMANS:** IF SWALLOWED, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. IF ON SKIN OR CLOTHING, take off contaminated clothing. **TOXICOLOGICAL INFORMATION:**
