DIRECTIONS FOR USE:

For control of fungi, bacteria and associated slime in pulp, paper or paperboard systems use 0.1 - 0.8 kg Nalcon 7648 per tonne of total paper (dry basis) production. Intermittent application to thick stock chests has proven most effective. Feed Nalcon 7648 directly from the drum or diluted with water. Application may be anywhere in the system prior to sheet formation or to the recirculating white water, provided uniform mixing occurs. If the product is applied manually, a dust mist respirator must be worn during application.

DO NOT use to treat paper or paperboard that will contact food.

PRECAUTIONS:
