PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN AND UNAUTHORIZED PERSONNEL.

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Harmful if swallowed.

Do not inhale vapours.

Dust may cause eye or skin irritation. Avoid contact with eyes, skin and clothing.

Wash well after handling and before eating, drinking and smoking. Wash contaminated clothing with soap and hot water before re-use.

FIRST AID

If swallowed: Call a poison control centre or doctor IMMEDIATELY for treatment advice. Have person sip a glass of water if able to swallow. **DO NOT INDUCE VOMITING** unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

STORAGE

Keep in original container during storage.
