**DIRECTIONS:** SHAKE BEFORE USING. FOR FLEAS AND TICKS: Remove soiled pet bedding and clean thoroughly or destroy. Spray sleeping quarters of pets, around baseboards, windows, door frames, wall cracks and floors. Spray rugs and carpets where flea infestations are bad. Repeat as necessary. Put fresh bedding in pet quarters after spray has dried. If used on light or delicate upholstery fabrics, test in an inconspicuous place prior to use.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Do not use near birds, fish, feed or foodstuffs. Avoid inhalation of spray, wash hands after use. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50°C.

**FIRST AID:** If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically. This product contains a petroleum distillate. Vomiting may cause aspiration pneumonia.

**DISPOSAL:** When container is empty, press valve to release all remaining pressure. Dispose of empty container with household garbage.
