DIRECTION FOR USE: This product is for the control of Darkling Beetles and Hide Beetles (lesser mealworms) in poultry houses or barns.

APPLICATION WITHIN THE POULTRY HOUSES OR BARNs: Apply insecticide using a duster suitable for crack and crevice treatments. Apply dust material directly into cracks and crevices such as wood plates, kneewalls, voids, switch boxes and posts. For treatment of infestation in outside walls, drill 3.22 cm hole about 1 m above floor level. Inject dust under pressure into void (space). For control of insects in the open, apply a visible film of powder on the floor, using a power duster. Apply only when poultry house or barn is empty and after litter has been removed. Repeat application annually. Wear dust mask or respirator. Apply uniformly at the rate of 1 kg per 100 m². Use at clean out only.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Store in a cool, dry, well ventilated place away from food and feed. Avoid contact with skin, eyes, and clothing. Wash thoroughly after handling and before eating, drinking and smoking. Avoid breathing dust. Do not contaminate food or feed. Do not contaminate any body of water. Do not spill or dump in areas underlain by roots of valuable plants.

FIRST AID: In case of poisoning, call a physician IMMEDIATELY or contact a poison control centre. **If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
