DIRECTIONS FOR USE: APPLICATION INSTRUCTIONS:

For dirt-floored grow out houses: Apply Polybor 3 dry with a fertilizer or seed spreader directly to soil at the rate of one kilogram per 10 square meters (two pounds per 100 square feet) when house is empty and after litter has been removed. Reapply annually at the rate of 1/2 kilogram per 10 square meters (one pound per 100 square feet). Prior to the warm season, apply Polybor 3 at the one kilogram (two pounds) rate to the surrounding 2/3 meter (two feet) outside the house under eaves. For interior sidewalls, mix Polybor 3 at the rate of one kilogram per 25 litres of water (two pounds per five gallons of water). Using a pressure sprayer, saturate cement sidewalls, top plates, posts and framing. Spray mix into cracks and crevices around installation. 600 litres of mix will cover a 1000 square meter house (125 gallons of mix will cover a 10,000 square foot house). Reapply spray annually or after each time a house has been disinfected. For best results, allow house to remain empty for at least two to four days before replacing litter. Wear a dust mask or a respirator and goggles when applying dust. Do not apply Polybor 3 directly to the litter. For layer houses and cement-floored grow out houses: Mix Polybor 3 at the rate of one kilogram per 25 litres of water (two pounds per five gallons of water). Using a pressure sprayer, saturate sidewalls, top plates, posts and framing. Spray mix into cracks and crevices around insulation. Apply at the rate of one kilogram of Polybor 3 (25 litres of mix) for each 20 square meter of treated surface (one pound of Polybor 3[2 1/2 gallons of mix] for each 100 square feet of treated surface). 100 to 150 kilograms will treat a 3000 square meter house (200 to 300 pounds will treat a 30,000 square foot house). Polybor 3 must be applied after each clean-out and after standard sanitation procedures have been completed. Do not apply directly to manure. NOTE: Prior to the warm season, apply Polybor 3 as a dust to the 2/3 meter (2 feet) outside the house under eaves at the rate of one kilogram per ten square meters (2 pounds per 100 square feet).
