DIRECTIONS FOR USE:

Routine Maintenance

1. Initial dosage for pool water having no visible algae is 90 mL of **BioGuard Back-Up** per 10,000 L of pool water.
2. Maintenance dosage is 15 mL per 10,000 L every week or alternatively 30 mL per 10,000 L of pool water, every two weeks.

DO NOT apply when swimmers are in the immediate vicinity (a 15-minute restricted-entry interval is recommended).

Swimming Pools with Visible Algae

For pool water having visible algae, chlorinate following label instructions of chlorinating product employed (step 1 and 2) and add 125 mL of BioGuard Backup per 10,000 L of pool water. Wait at least 15 minutes before re-entering the pool.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Do not mix with any other chemical. Corrosive to eyes. Do not get in eyes, on skin or on clothing. Wear goggles and rubber gloves when handling this concentrate. Avoid contamination of food.

FIRST AID: If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If in eyes,** hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If swallowed,** call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: Rinse the container thoroughly before discarding. Do not re-use empty container. Offer for recycling if available. Wrap and dispose of empty container with household garbage. For information on the disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency.
