#### PRECAUTIONS CAUSES EYE DAMAGE HARMFUL IF SWALLOWED PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

Do not get in eyes, on skin or clothing. Wear goggles or face shield when handling. Avoid breathing dust. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

### FIRST AID

# Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled**: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If in eyes**: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

# **TOXICOLOGICAL INFORMATION**

No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient. High concentrations of MCPA may cause severe irritation to the eyes. Symptoms of overexposure to MCPA could include slurred speech, twitching, jerking and spasms, drooling, low blood pressure and unconsciousness. Treat symptomatically.

Do not ship or store with food, feeds, drugs or clothing.
