#### **APPLICATIONS**

For the control of wasps, bees, hornets and yellow jackets.

#### **DIRECTIONS:**

NOT INTENDED FOR HOUSEHOLD USE. USE ONLY AS DIRECTED ON THIS LABEL. SHAKE BEFORE USE. Remove protective cap. Direct blast at nest or insects. Application to nests should be carried out in late evening or early morning (if possible) when insects are at rest. Saturate nests from a distance of 2 to 3 metres. **TOXICOLOGICAL INFORMATION:** Propoxur is a carbamate which is a cholinesterase inhibitor. Typical symptoms of overexposure to cholinesterase inhibitors include malaise, muscle weakness, dizziness and sweating. Headache, salivation, nausea, vomiting, abdominal pain and diarrhea are often prominent. A life-threatening poisoning is signified by loss of consciousness, incontinence, convulsions and respiratory depression with a secondary cardiovascular component. Treat symptomatically. If exposed, plasma and red blood cell

> cholinesterase tests may indicate degree of exposure (baseline data are useful). However, if a blood sample is taken several hours after exposure, it is unlikely that blood cholinesterase activities will be depressed, due to rapid reactivation of cholinesterase. Atropine, only by injection, is the preferable antidote. Do not use pralidoxime. In cases of severe acute poisoning, use antidotes immediately after establishing an open airway and respiration. With oral exposure, the decision of whether to induce vomiting or not should be made by an attending physician.

**DISPOSAL:** When empty, depress valve to release remaining pressure. Do **NOT** throw in fire. Dispose of emptied container in accordance with provincial requirements.
