DIRECTIONS FOR USE: Insects Controlled: aphids, earwigs, mealybugs, spider mites, psyllids, rose and pear slugs, soft brown scale and whiteflies.

Mixing: Stir one part of Green Earth[®] Insecticidal Soap into 20 parts of water – i.e., 50 mL Soap to 1 litre water (2 tablespoonfuls per pint).

Spraying: Use a fine spray to thoroughly cover both sides of leaves and stems.

Dipping: Small potted plants may be upended, using your hand to hold soil, and dipped or gently swilled through a solution of Green Earth[®] Insecticidal Soap mixed at 50 mL per litre of room temperature water.

Timing: Use weekly until control is observed.

NOT recommended on Ferns, Nasturtiums, and Sweet Peas. If in doubt about any delicate plant, such as **roses, seedlings** and **transplants**, apply to several leaves as a pretest. Allow sufficient time to determine if plant damage occurs before spraying the entire plant two before spraying the. Do not spray open blooms. Do not apply during full sun or high heat.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Wash fruits and vegetables before eating. Avoid contact with skin and eyes.

FIRST AID: If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin or clothing,** take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.
