DIRECTIONS FOR USE: To be used only in the manufacture of a pesticide registered under the *PEST CONTROL PRODUCTS ACT*.

PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Harmful if swallowed. May cause skin and eye irritation. Avoid contact with skin, eyes and clothing. Wear protective goggles and gloves when handling. Wash hands and exposed skin thoroughly after handling.

FIRST AID:

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

In case of skin or clothing contact, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

High concentrations of MCPA may cause severe irritation to the eyes. Symptoms of overexposure to MCPA could include slurred speech, twitching, jerking and spasms, drooling, low-blood pressure and unconsciousness. Treat symptomatically.

DISPOSAL: Canadian formulators of this technical should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean up of spills.

SPILL CLEAN-UP:

Keep bystanders away. Do not smoke, drink or eat during clean-up operations. Wear protective equipment (respirator, coveralls, rubber boots and protective gloves). Absorb the liquid onto soil, sawdust or other suitable absorbent material and shovel into a drum. Add broken packages to the drum and seal for removal to an approved disposal site. Wash site with water and mop up into a drum for disposal to an approved disposal site. Remove and wash all protective clothing and equipment. Shower and wash thoroughly with soap and water on completion of mopping up operation.
