DIRECTIONS FOR USE:

SHAKE BOTTLE WELL BEFORE EACH USE

Use in greenhouses or indoors on houseplants. Use throughout the growing season or as a preharvest treatment for edibles when other insecticides are prohibited due to residue restrictions. MAY BE APPLIED UP TO THE DAY OF HARVEST, EXCEPT GREENHOUSE CUCUMBERS, LETTUCE AND TOMATOES. **DO NOT SPRAY IN HOT SUN OR IN TEMPERATURES OVER 32°C.**

TO CONTROL INSECTS: Water plant thoroughly before application. Turn spray nozzle to "ON" position. Hold bottle 30 cm from plant and spray lightly covering upper and lower leaf surfaces, stems, plant base and soil. Test on one or two leaves to determine safety. Do not spray on blooms or buds. Repeat treatments weekly or as needed to control infestation. Use caution on tender, young plants and foliage. Important to apply at first notice of infestation. Insects must be contacted directly by spray to be killed. Apply in early morning or evening - not in direct sunlight.

Insects Controlled: Whiteflies, Red Spiders, Aphids, Thrips, Moths, Gnats, Leaftiers, Spider Mites, Fern Scales, Beetles, Leafhoppers.

Indoor and Greenhouse Plants: African Violets, Azaleas, Begonias, Camellias, Carnations, Chrysanthemums, Fuchsias, Geraniums, Ivy, Kentia Palm, Marigolds, Roses, Rubber Plants, Salvia, Wandering Jews, Zinnias.

Greenhouse Vegetables: Tomatoes, Peppers, Carrots, Lettuce, Cucumbers, Radishes, Onions, Asparagus, Beans, Cabbage, Squash, Herbs.

PRECAUTIONS: Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. Remove pets, birds and cover fish aquaria before spraying. This product is toxic to fish. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes.

FIRST AID: If in eyes hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.
