DIRECTIONS FOR USE: Shake Well Before Using. Apply with the hand trigger sprayer attached. Adjust nozzle to suitable spray pattern. Use in greenhouses or indoors on houseplants, throughout the growing season.

Spray to thoroughly cover upper and lower leaf surfaces. Repeat treatment weekly or as needed to control infestations. Use with caution on tender young plants and foliage. Test on one or two leaves to determine safety. Apply in early morning or evening - not in direct sunlight. Spray only when air is still and temperature is below 32°C. Insects must be contacted directly to be killed- no residual effect.

Insects Controlled: aphids, flea beetles, leafhoppers, whiteflies, spider mites, rose chafers, tarnished plant bugs.

Ornamentals: African violets, asters, azaleas, begonias, camellias, carnations, chrysanthemums, crassula, dahlias, delphiniums, dogwood, English ivy, euonymous, fuchsia, geranium, gladiolus, Kentia palm, laurel, rhododendron, rose, rubber plant, snapdragon, stocks, wandering Jew, zinnia.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing spray mist. Avoid contact with skin and eyes. This product is toxic to fish. When spraying in rooms, cover fish bowls and remove pets for one hour.

FIRST AID: If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin or clothing,** take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **If swallowed,** call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.
