#### **GENERAL INFORMATION**

ROUNDUP Quik Stik, a non-selective vegetation control herbicide, when dissolved in water controls most annual and perennial grasses, including lawn grasses, broadleaf weeds and brush (i.e., virtually anything that is green and growing). A systemic herbicide, it is absorbed by the leaves and moves throughout stem and roots to control the entire plant. Visible symptoms of control will occur within 3 days with complete kill in 2-4 weeks. For best results, apply to actively growing plants in sunny weather. One application will control most weeds. If certain hard-to-control weeds are not completely killed within 4 weeks, repeat application. Treated areas can be reseeded or replanted 3 or more days after application.

**NOTE**: ROUNDUP has no soil activity and will not leach or run off to affect nearby vegetation. Plants must be present to be controlled. Repeat applications will be required as new seedlings and vegetation emerge.

# **CAUTION:**
