**DIRECTIONS FOR USE**

To be used only in the manufacture of insecticides which are registered under the Pest Control Products Act. This product is to be used with appropriate solvents and or carriers, and in the case of pressurized products, propellents, to produce an insecticide product.

**PRECAUTIONS:** KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL. Harmful if swallowed or absorbed through skin. Do not breathe vapors or spray mist. Avoid contact with skin or eyes. In case of contact, flush with plenty of water. Wash with soap and water after use. Obtain medical attention if irritation persists. Avoid contamination of food or feedstuffs. This product is toxic to fish. Do not apply directly to any body of water. Do not contaminate water by cleaning of equipment or disposal of wastes.

**FIRST AID:** In case of contact on skin or clothing take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If ingested call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
