4. Place by ant trails where ants are numerous.
5. For Garden & Lawn: Place along trails & ant colonies. Put traps 3-6 meters apart.

In 3-7 days ants will be killed. Replace with new traps every 30 days. Avoid contamination of feed and foodstuff.

STORAGE AND DISPOSAL STATEMENT:

STORAGE–Store in original container away from food and feedstuffs. Keep product in a locked storage area inaccessible to children and pets.
