FOR USE ON CRAWLING INSECTS such as ants, cockroaches, earwigs, fleas, spiders, centipedes, bedbugs, carpet beetles, silverfish and crickets.

DIRECTIONS: SHAKE WELL BEFORE USING. Hold container about 30 cm from surface being sprayed and spray until wet. Keep children and pets away from treated surfaces until dry. For spot treatment spray outside and inside house wherever crawling insects may enter or hide, such as door sills, baseboards, window frames, cracks and crevices in floors and walls, surfaces around pipes, behind and beneath cabinets, refrigerators, sinks, stoves etc. Do not use in food storage areas or on surfaces that may contact food. Spray ant trails and hills. Repeat as necessary. For carpet beetles, treat underside of carpets, floors, baseboards, cracks, crevices, closets and infested areas of shelving. Repeat treatment as necessary. **DO NOT USE ON RUBBER-BACKED CARPETS.**

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Wash hands after use. Do not use as a space spray. Do not use on humans, pets or foodstuffs. Do not contaminate food, utensils, food preparation surfaces, or fish bowls. Do not inhale spray. Spray harmful or fatal if inhaled. **CONTENTS UNDER PRESSURE.** Do not place container in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50°C. Keep away from open flame or spark.

FIRST AID: If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically. Contains petroleum distillate. Vomiting may cause aspiration pneumonia.

DISPOSAL: When empty press button to release pressure, dispose of in household garbage.
