DIRECTIONS FOR USE:

In all applications, cut or tear open the Outer bag to expel the **2K7 Water Soluble Paks** into the system in the areas specified below:

Paper Mills:

2K7 Water Soluble Paks should be used at 30-50 g per tonne of dry paper produced at least once per day

Oilfield Applications:

Use 100 ppm active ingredient based on the water content of the system until control is achieved. Maintenance dosage 10-25 ppm.

Oil Storage Tanks:

Cut or tear open the outer bag and drop **2K7 Water Soluble Paks** through thief hatch.

Heat Exchangers, Cooling Towers, Condensers, Air Washers:

Pre-clean heavily fouled systems (e.g. with chlorine). Shock dosages of 100 ppm based on the water content of the system may be used until control is achieved. Maintenance dosage 15-50 ppm. Cut or tear open the outer bag to expel the **2K7 Water Soluble Paks** directly into the sump of the system at a convenient point.

FIRST AID:

If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.
