**EXPLOSIVE

For use as a spot or crack and crevice treatment to control insects listed on front panel.

**GENERAL DIRECTIONS:**

Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vapourize into cracks and crevices for insect control. If reinfestation occurs, repeat applications as necessary. Use as a surface spray. Provide adequate ventilation after indoor use. KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY.

INDOOR USE:

Thoroughly treat cracks, crevices and spots along and behind baseboards, underneath furniture and equipment, around garbage containers, localized areas of floors and floor coverings and other places where insects hide or are seen.

OUTDOOR USE:

Spray spots on outside surfaces of screen frames, doors, window frames, foundations, patios, light fixtures and other places where insects may alight, or congregate and enter. Cluster flies and houseflies will be killed when they land on treated surfaces.

**PRECAUTIONS:**
